This registration has been issued based on the understanding that:

- The registration is valid for the following types of valves V-500, V-632 and V-910 made of A-479 316 or A-351 CF3M:
- The pressure ratings are as follows: 10,000 psi @ 100 F, 8,000 psi @ 450 F and 1,500 psi @ 1,000F. Other intermediate pressure ratings can be established based on the ambient pressure (10,000 psi @ 100 F) and the allowable stress at temperature for the material specification as per B31.1. The derating to be as per UG-101(k).

As indicated on AB-41 Statutory Declaration or AB-351 Declaration of Conformity form and submitted documentation, the code of construction is ASME B31.3.
